



Volunteer Waiver

Waiver and Agreement In consideration of being permitted to volunteer with or assisting others in participating in **A Pet's Pantry** and related events and activities, on behalf of myself, or a minor child or ward, heir, next of kin, personal representative, successor or assign;

(1) I ACKNOWLEDGE, UNDERSTAND, DECLARE AND AGREE THAT:

(a) To the best of my knowledge, I am in Good Physical Condition and have no disease or injury that would be aggravated by participating/volunteering in activities related to **A Pet's Pantry**;

(b) Participating/volunteering or assisting others in participating/volunteering for **A Pet's Pantry** may involve RISK OF INJURY TO ME, INCLUDING DEATH, LOSS OR DAMAGE TO ME OR MY PROPERTY, or other consequences, which might result not only from my own actions, inaction or negligence but also the actions, inaction or negligence of others or the conditions of the premises or of any equipment used;

(c) There may be OTHER RISKS not known or not reasonably foreseeable; and Understanding All of the Above,

(2) I ASSUME ALL OF THE ABOVE RISKS AND RELEASE, WAIVE, DISCHARGE, HOLD HARMLESS, INDEMNIFY AND COVENANT NOT TO SUE:

(a) **A Pet's Pantry**, employees or volunteers, affiliated with the organization, agencies, sponsors, or advertisers, the respective administrators, officers, directors, agents, employees, volunteers, or any other individuals affiliated **A Pet's Pantry**;

(b) any affiliated subsidiary, successor, organization, or related companies or businesses, other participants, participating or sponsoring municipalities, governmental agencies, international organizations, agencies, sponsors, or advertisers, the respective administrators, officers, directors, representatives, employees or volunteers of such entities or organizations;

(c) owners, lessors and lessees of premises used to conduct the programs provided by **A Pet's Pantry** FROM ANY AND ALL LIABILITY FOR INJURY, INCLUDING DEATH, LOSS OR DAMAGE TO PERSON OR PROPERTY, OR ANY OTHER CONSEQUENCE in connection with entry in or arising out of participation in, performance in or lack of performance in, including travel en route to and from volunteer engagements on behalf of **A Pet's Pantry**.

(3) I FURTHER AGREE THAT: Prior to participating as a volunteer, I, or in the case of a minor, a parent or guardian, will INSPECT the facilities and equipment to be used, and if I believe same to be unsafe, REPORT such condition(s) to a representative of the Board of Directors for **A Pet's Pantry** and either DECLINE TO PARTICIPATE or ASSUME THE RISK of participating;

(4) I will ALLOW my NAME, PHOTOGRAPH, PICTURE or LIKENESS and/or VOICE to APPEAR online or in any official documentary, promotional (including any and all advertisements), television, radio or film coverage of **A Pet's Pantry** without compensation or notice. I understand that IF I have reason to opt out of this allowance or any portion hereof, I will inform the Board of Directors immediately and in writing. (This written notice will then be attached to this form as an addendum and conditions therein honoured by **A Pet's Pantry**, in accordance with PIPA regulations.)
